2011 POOL PASS INFORMATION

ALL residents over the age of 2 MUST have a picture pool pass in order to obtain admission to the pool. Residents may NOT use a guest pass.

Residents who previously had pool passes must have them validated for the current season. New residents are provided their initial set of pool passes free of charge. Replacement passes will be provided at a cost of \$5.00 each if we take the picture or \$3.00 each if you supply the picture. Pool passes for the 2011 season will be issued and validated on the dates listed below. **Proof of residency may be required.**

Residents who already have pool passes that simply need to be validated for the new season have the option of mailing the passes to us (additional postage may be required) for validation along with their **completed Resident Update form. We will NOT return passes via mail service. You may pick them up at the shelter during the times above or they will be available for pick up during pool hours at the lifeguard table.**

IMPORTANT INFORMATION REGARDING “ASSOCIATION RULES”:

1. **ALL** outstanding dues, fines, liens and judgments must be paid in full and all Architectural Violations must be resolved before pool passes are issued.
2. **TENANTS:** Written documentation must be received from your landlord or property manager before pool passes will be obtained.
3. **Residents** with ACC violations during the season will have pool passes revoked until such violation is remedied.
4. **Residents with existing pool passes should have them validated prior to pool season, otherwise, it could take up to 2 weeks to have them validated.**
5. **NEW residents:** If pictures are provided (**1” square**), you may leave them with the lifeguard along with a completed form and passes will be available within 2-4 days. A temporary pass will be available from the lifeguards. If pictures are needed, a schedule will be available from the lifeguards as to when photos will be taken.
6. **Cloth and standard disposable diapers** are prohibited for use at the community pool. All non potty-trained children must wear swim diapers or the “special” disposable swim diapers.
